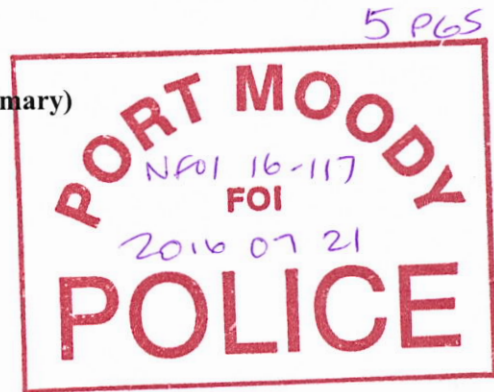

On 2010-06-14 at 1121 hours, Cst WORMALD was dispatched to the front counter of the Port Moody Police Department to speak with 22 regarding a possible threats at 560 Foress Dr in Port Moody. Cst WORMALD attended the counter and spoke with 22 who advised that 22 had a verbal argument with 22 D.BERLADYN on 2010-06-11. The argument was about the following:

- 22 wants 22 D.BERLADYN to move out of the family home  
-D.BERLADYN wants all the money he has paid towards rent for the last ten years so he can use the money to assist with his financial situation

22 further advised that 22 D.BERLADYN had been swearing at 22 on 2010-06-11 while inside the family home and wanted money. However, no threat was uttered (just swear words ie: "your a fucking 22"). 22 also advised that 22

Cst WORMALD advised 22 that he could speak with D.BERLADYN at a later date if it was required. Cst WORMALD further advised that a trip to the family doctor re: bi-polar disorder medication may assist family.
